1. Statement of Significant Accounting Policies.

Receivables and payables in the Balance Sheet are shown inclusive of GST if applicable.

Impact of COVID-19 on Operations

The overall impact of COVID-19 on the future financial performance and position of the Yeppoon Surf Life Saving Club Inc. cannot be reliably determined. The Committee continue to monitor the situation but do not, at this time believe that there will be significant impact on ongoing operations as it stands.
